I, _____ hereby acknowledge the rules and regulations **below** as established by Last Chance Wrecker & Sales. I also acknowledge that my buying privileges can be and will be determined by breaking any rule or regulation listed below or announced at the beginning of the sale period.

1) **ALL UNITS ARE FOR SALE TO THE GENERAL PUBLIC.**

2) **ALL UNITS ARE SOLD AS IS: WITH ABSOLUTELY NO WARRANTY EXPRESSED, WRITTEN OR IMPLIED.** YOU ALSO UNDERSTAND THE ACTUAL ODOMETER READING CAN NOT BE VERIFIED FOR THE PURPOSE OF SALE OR TITLE.

3) A \$100.00 CASH DEPOSIT IS REQUIRED AND WILL ONLY BE REFUNDED TO YOU AS LONG AS YOU HAVE NOT MADE A PURCHASE AND AS LONG AS YOU RETAIN YOUR RECEIPT. IF YOU LOSE YOUR RECEIPT, THEN YOU WILL LOSE YOUR DEPOSIT. IF YOU DO PURCHASE VEHICLES THE DEPOSIT WILL BE USED TOWARDS THE PURCHASE AS LONG AS YOU RETAIN YOUR RECEIPT.

4) IF YOU BID ON VEHICLES AND THEN DON'T PAY FOR THEM THEN YOU WILL FORFEIT YOUR DEPOSIT AND WILL BE PLACED ON A \$250.00 DEPOSIT FROM THEN ON.

5) THERE IS A \$50.00 BUYER'S FEE ADDED TO EACH VEHICLE SOLD (UNLESS ANNOUNCED AT TIME OF SALE). THE \$50 BUYER'S FEE IS UP TO \$1,000.00. ANYTHING OVER THAT PRICE, THE BUYER'S FEE WILL BE 5% OF PRICE. THERE IS ALSO A \$15.00 TITLE APPLICATION FEE IF YOU WANT TO TITLE THE VEHICLE AND A \$15.00 KEY CHARGE IF YOU WANT THE KEY TO THE VEHICLE.

6) **ALL UNITS MUST BE PAID FOR AND REMOVED BY CLOSED OF BUSINESS ON MONDAY. ALL UNITS MUST BE PAID FOR IN CASH. ANY VEHICLE LEFT AFTER MONDAY WILL BE SOLD AT THE NEXT AUCTION, WHETHER YOU HAVE PAID FOR THEM OR NOT, IF PAID FOR AND LEFT YOU WILL LOSE ALL MONIES PAID ON THE VEHICLE.**

7) **ALL UNITS THAT HAVE EPA FAIL ON THEM MEANS YOU WILL NOT BE ABLE TO GET A TITLE APPLICATION ON THEM UNTIL THE UNITS HAVE BEEN BROUGHT UP TO EPA STANDARDS (THIS DOES NOT APPLY TO DEALERS).**

8) **ANY PERSON TAMPERING WITH UNITS WILL BE BANNED FROM THE SALE AND PROSECUTED TO THE FULLEST EXTENT OF THE LAW. ALL BUYERS AND GUESTS MUST STAY IN THE SALE AREA.**

9) **ANY UNITS SOLD WITHOUT A PUBLIC VIN MAY NOT LEAVE OUR FACILITY UNTIL NEW VIN PLATE HAS BEEN ATTACHED BY CORE AUTO THEFT. YOU WILL NOT BE CHARGED FOR STORAGE FOR THE FIRST 30 DAYS.**

10) **TITLE APPLICATIONS CAN ONLY BE IN THE NAME OF THE PERSON THAT BIDDED ON THE UNIT. NO OTHER NAMES WILL BE ADDED OR CHANGED ON TITLE APPLICATIONS.**
